- MRF Operations Update
 - Operations are running smoothly with no issues.
 - OCC prices dropped by \$5.
 - Fiber dropped by \$10 last month.
 - Mixed paper saw a decrease.
 - Aluminum increased by \$100.
 - HDPE natural saw an uptick.
 - Price trends are expected to hold steady through the end of the year.
 - Arlene inquired about the typical holiday increase in prices.
 - WM Marketing Representative anticipates prices will remain stable.
 - Currently, all materials are staying domestic.
 - The recent port strike caused delays, but the MRF faced fewer challenges compared to other facilities due to proactive planning by WM.

- MRF Contract:
 - 20% of communities have signed contracts; progress continues with an end-of-year deadline approaching.
 - Efforts are underway to manage transportation costs in Southern Berkshires.
 - Identifying a new transporter for Southern Berkshires.
 - Linda is currently searching for cost-effective hauling options for Northern Berkshire towns.
- Treasurer's Report
 - We are stable.
 - Payments for the website and social media personnel are up to date.
 - Operating with low monthly expenses.

- Board Vacancies
 - Liz Bone, Recycling Coordinator for East Longmeadow, introduced and expressed interest in filling a vacancy.

 - Unanimously approved.

- Berkshire RRR Update
 - The Berkshire RRR publication received positive feedback:

 - Learning curve for the Berkshire Eagle team resulted in minor hiccups, but overall success.
 - Recommendation: Meet in January to review content and plan for future RRR's.
